- _____ The location and species associations of all existing individual trees or groups of trees having a caliper of six inches or more measured three feet above ground level. The proposed location of all proposed plantings shall be indicated and a legend provided listing the botanical and common names, the sizes at time of planting, the total quantity of each plant, and the location of each plant keyed to the plan or plat

- _____ Environmental impact statement (See § 215-83C.): All preliminary major subdivision and/or preliminary major site plan applications shall be accompanied by an environmental impact statement, unless specifically waived by the Planning Board or the Zoning Board of Adjustment, as the case may be
- _____ The Board reserves the right to require additional information before granting preliminary approval when unique circumstances affect the tract and/or when the application for development poses special problems for the tract and the surrounding area. Such information may include, but not be limited to, drainage calculations and traffic analyses; provided, however, that no application shall be declared incomplete for lack of such additional information
