**ORDINANCE(S) FOR SECOND READING, PUBLIC HEARING AND FINAL ADOPTION**

- The Clerk read (**Ordinance #15-03**) AN ORDINANCE AMENDING THE EWING TOWNSHIP SALARY ORDINANCE ESTABLISHING COMPENSATION OF OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF EWING

BE IT ORDAINED by the Township Council of the Township of Ewing that the Salary Ordinance establishing compensation of Officers and Employees of the Township of Ewing is hereby amended as follows:

Section 1. The following phased Salary increase is hereby established for the compensation of Members of the Township Council and Council President:

Section 2. The following phased Salary increase is hereby established for the compensation of the Mayor/Director of Public Safety:

Section 3. This Ordinance shall be retroactive to January 1, 2015, and shall become operative in 20 days after publication according to law pursuant to N.J.S.A. 40A:9-165.

STATEMENT

This Ordinance amends the Salary Ordinance of the Township of Ewing for the positions of Member of Council, Council President, and Mayor.

**Mr. Baxter made a motion to open the Public Hearing, seconded by Mr. Schroth. It was agreed by unanimous voice vote.**

**Faye Ball (47 Somerset Street) asked when was the first reading.**

**President Keyes-Maloney replied that it was at the last Council meeting on February 24<sup>th</sup>.**

**Ms. Ball said that she would not have known from the title as it is listed on the Agenda that it was a salary increase for Mayor and Council. Ms. Ball said that she thought it was for “regular” Township employees.**

**George Steward (30 Gilmore Road) said that this is an excellent example for Council to hold two separate meetings on two separate nights. Mr. Steward reiterated that he is opposed to Agenda and Regular Session Council meetings being held on the same night, only minutes apart.**

**Les Summiel (13 Lanning Street) urged Council to defeat this motion for reasons articulated during the Agenda Session. Mr. Summiel suggested that Council form an Advisory Panel concerning this issue. Mr. Summiel said that the Public is not being served if this passes this evening.**

**There were no additional questions or comments from members of the Public. Mr. Baxter made a motion to close the Public Hearing, seconded by Ms. Wollert. It was agreed by unanimous voice vote.**

**President Keyes-Maloney stated that there has been some conversation to amend this Ordinance in light of the conversation that we had this evening. President**

Keyes-Maloney said that Council is considering phasing in the salary increase along with making it, at least in part, effective for the future. This will be advertised and there will be another Public Hearing at our meeting on the 24<sup>th</sup>.

Vice President Schroth commented that Council has taken this very seriously; none of us enjoy this process. Extensive research has been done on this issue. Vice President Schroth said that the objective is to get Council to where it should be, it is not Council seeking to increase their salary in any way that is disproportionate to the work that is done. Council has looked at Cost of Living adjustments. Mr. Schroth added that it is great that everyone is here tonight. It was advertised; virtually no one was here at the February meeting. Unfortunately, that is often the case at these Council meetings, even when very serious issues are being discussed.

Councilman Baxter said that Council has listened to what was said tonight. It is a touchy subject; to vote for your own raise but we are tasked with a job to do. This will be looked at from a different angle. Mr. Baxter then asked that the Public attend more Council meetings, particular those concerning the Budget. Councilman Baxter also asked the Public to show up at school board budget meetings as that is the largest chunk of the tax dollar. Councilman Baxter then thanked the Public for coming tonight.

Councilwoman Wollert thanked the Public for their comments and said that these comments are being taken into consideration. Ms. Wollert said that this conversation has been brought up in the past, but Council did not move the issue forward in the face of negative comments.

Councilwoman Steward said that she is grateful that this is being reviewed to see how this can be more closely aligned with the public comments heard tonight.

President Keyes-Maloney said that she fundamentally believes that Council has the authority and the responsibility to handle this issue. Ms. Keyes-Maloney also said that the Township needs a full-time mayor. Council will work with the Public to come up with a solution that meets as many of the concerns brought up this evening while staying within the spirit of what was initially proposed.

There were no additional questions or comments from Council.

The Attorney asked if Council is going to carry this Ordinance forward or amend it this evening.

President Keyes-Maloney replied – amend it.

The Attorney then gave a detailed account of the amendment: the current salary for the Council President is \$7,556.00. It will increase \$1,814.66 each year for three years beginning January 1, 2015. The current salary for the Council Vice President is \$6,296.00. It will increase \$2,068.00 each year for three years beginning January 1, 2015. The current salary for Council members is \$6,296.00. It will increase \$1,901.33 each year for three years beginning January 1, 2015. The current salary for Mayor/Director of Public Safety is \$17,850.00. It will increase \$10,716.66 each year for three years beginning January 1, 2015.

Ms. Wollert made a motion to amend the Ordinance, seconded by Mr. Schroth. President Keyes-Maloney asked for a roll call.

**2. The Clerk read (Ordinance #15-04) BOND ORDINANCE AMENDING SECTION 3(A) AND 6(B) OF BOND ORDINANCE NUMBERED 14-06 OF THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, NEW JERSEY FINALLY ADOPTED MAY 27, 2014 PROVIDING FOR THE ACQUISITION OF CERTAIN VEHICLES AND EQUIPMENT IN ORDER TO AMEND THE DESCRIPTION OF THE PROJECT, THE USEFUL LIFE OF THE PROJECT AND THE AVERAGE USEFUL LIFE**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(a) (second paragraph) of Bond Ordinance numbered 14-06 of the Township of Ewing, in the County of Mercer, New Jersey (the "Township"), finally adopted May 27, 2014, is hereby amended in its entirety to read as follows:

Acquisition of various equipment and vehicles, including an air compressor, a mower, fencing, bleachers and dual wheel Ford F350 pickup trucks with snow plows and salters, including all related costs and expenditures incidental thereto.	\$247,000	\$234,650	5 years"

Section Two. Section 6(b) of Bond Ordinance numbered 14-06 of the Township, finally adopted May 27, 2014, is hereby amended to read as follows:

"The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 9.88 years."

Section Three. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with

the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

**President Keyes-Maloney said that this allows us to purchase a number of items including an F150 in light of the fact that we are not purchasing a piece of equipment for Public Works.**

**There were no questions or comments from Council.**

**Ms. Wollert made a motion to open the Public Hearing, seconded by Mr. Baxter. It was agreed by unanimous voice vote.**

**Les Summiel (13 Lanning Street) asked what is the total cost of this Bond Ordinance.**

**President Keyes-Maloney said that it was a previously approved Bond Ordinance, we are just changing what is being purchased.**

**There were no additional questions or comments from members of the Public. Mr. Schroth made a motion to close the Public Hearing, seconded by Mr. Baxter. It was agreed by unanimous voice vote. Ms. Wollert then moved the Ordinance, seconded by Ms. Steward. President Keyes-Maloney called for a roll call.**

- 3. The Clerk read (Ordinance #15-05) BOND ORDINANCE PROVIDING A SUPPLEMENTAL APPROPRIATION OF \$170,000 FOR THE ACQUISITION OF FIRE TRUCKS AND OTHER EQUIPMENT IN AND BY THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, NEW JERSEY, AND AUTHORIZING THE ISSUANCE OF \$161,500 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF**

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The improvements described in Section 3(a) of this bond ordinance have heretofore been authorized to be undertaken by the Township of Ewing, in the County of Mercer, New Jersey (the "Township") as general improvements. For the improvements or purposes described in Section 3(a), there is hereby appropriated the supplemental amount of \$170,000, such sum being in addition to the \$2,322,950 appropriated therefor by Sections 3(e) (first paragraph), 3(f) (first paragraph) and 3(g) (first paragraph) of Bond Ordinance #14-06 of the Township, finally adopted May 27, 2014 (the "Original Bond Ordinance"), and including the sum of \$8,500 as the additional down payment required by the Local Bond Law. The additional down payment is now

available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the additional cost of the improvements or purposes not covered by application of the additional down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$161,500 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. (a) The improvements heretofore authorized and the purpose for the financing of which the bonds are to be issued are: 1) the acquisition of a fire truck and a thermal imaging camera for the Prospect Heights Fire Company, including all related costs and expenditure incidental thereto, 2) the acquisition of a fire truck for the Pennington Road Fire Company, including all related costs and expenditures incidental thereto and 3) the acquisition of various equipment, including a fire truck, a thermal imaging camera and pagers, including all related costs and expenditures incidental thereto.

(b) The estimated maximum amount of bonds or bond anticipation notes to be issued for the improvements or purposes is \$2,368,835.21, including the \$2,207,335.21 authorized by Sections 3(e) (first paragraph), 3(f) (first paragraph) and 3(g) (first paragraph) of the Original Bond Ordinance and the \$161,500 bonds or bond anticipation notes authorized herein.

(c) The estimated cost of the improvements or purposes is \$2,492,950, including the \$2,322,950 appropriated by Sections 3(e) (first paragraph), 3(f) (first paragraph) and 3(g) (first paragraph) of the Original Bond Ordinance and the \$170,000 appropriated herein.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes



issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3(a) of this bond ordinance are not current expenses. They are improvements or purposes that the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The period of usefulness of the improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is 10 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in

this bond ordinance by \$161,500, and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.

(d) An additional \$10,000 is being estimated herein for items of expense listed in and permitted under N.J.S.A. 40A:2-20.

Section 7. The Township hereby declares the intent of the Township to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3(a) of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purpose described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Township is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Township and to execute such disclosure document on behalf of the Township. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Township pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the *ARule*) for the benefit of holders and beneficial owners of obligations of the Township and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Township fails to comply with its undertaking, the Township shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

President Keyes-Maloney stated that this will allow us to modify our existing bond ordinance for the acquisition of these particular fire trucks in light of the fact that the cost exceeded what we have estimated under the original bond ordinance.

There were no questions or comments from Council.

Mr. Baxter made a motion to open the Public Hearing, seconded by Mr. Schroth. It was agreed by unanimous voice vote. There were no questions or comments from members of the Public.
