Business Administrator McManimon said that one item of discussion given to the Clerk and sent to your Dropbox was about the Bond Sale today. We had five companies that bid but there were 15 bids placed on the process. You only see what position you are in so you can't just automatically undercut the #1. They were all great rates. We did this four years ago when we had just gotten our AA rating back and were at 2.2. Last week the rate would have been 1.8 but the winning bid today is 1.589%. Our Phoenix Advisors met our Bond Counsel today and Joanna was on the phone and on the computer from home. He said that these kinds of interest rates are great. He said it pays off notes with higher interest rates and we keep our debt service flat. He said that next time you see Joanna she deserves Kudos for what she does.
