Disclosure requirement: Pursuant to Ewing Township Ordinance No. 06-19, this disclosure must include all contributions made to or on behalf of any candidate, candidate committee, joint candidates committee, political committee, continuing political committee or political party committee of, or pertaining to, the Township of Ewing made up to one (1) year prior to filing a variance application and/or during the pendency of the application process, and required to be reported pursuant to N.J.S.A. 19:44A-1 et seq.

For all developers, any applicant for a variance pursuant to N.J.S.A. 40:55D-70(d) or a variance pursuant to N.J.S.A. 40:55D-70(c) in conjunction with any application for a subdivision not considered a minor subdivision or a site plan not considered a minor site plan as well as any application for a subdivision not considered a minor subdivision or site plan or subdivision not considered a minor site plan requiring waivers or exceptions pursuant to N.J.S.A. 40:55D-51 shall include this form in the application. These disclosure requirements shall also apply to all associates of said developers who would be subject to disclosure pursuant to N.J.S.A. 40:55D-48.1 or 40:55D-48.2 and to all professionals who apply for or provide testimony, plans or reports in support of said variance and who have enforceable proprietary interest in the property or development which is the subject of the application or whose fee in whole or part is contingent upon the outcome of the application.
